如您隸屬於 - 國立臺灣大學 (National Taiwan University)，您可以在劍橋金色 OA (Gold OA) 期刊與混合 (Hybrid) 期刊上免費以開放獲取形式 (Open Access) 發表您的文章。此外，您還可以使用劍橋大學出版社的期刊全文。

符合以下條件，您即可免費發表 OA 文章：

- 文章的通訊作者隸屬於國立臺灣大學。(提醒：投稿時，Institution 請選擇 National Taiwan University，並請使用帶有 *.ntu.edu.tw、*.ntuh.gov.tw、hch.gov.tw、ms1.ylh.gov.tw、ntucc.gov.tw 的 E-Mail。)
- 文章是原創性研究，適用的文章類型包括 Research Articles、Review Articles and Rapid Communications、Brief Reports and Case Reports。
- 文章需投稿至 2025 OA 協議所列期刊。(2025 總刊數 435 刊，包含 260 本 Hybrid OA 刊 + 167 本 Gold OA 刊)
- 文章在協議有效期內被確認接受。(有效期為 2024/1/1 至 2026/12/31。)

您在劍橋大學出版社發表 OA 文章的 APC 免除流程

1. 當投稿文章被接受之後，作者會收到一封信：

作者需透過信上連結決定是否要以 OA 形式出版文章，並完成版權合約的簽訂。

Complete Open Access agreement, select a creative commons licence and return to Content Manager (production contact)

Author publishing agreement

Before Cambridge University Press can publish a journal article (or any other journal content type) we need a signed licence to publish. To find the right form, start by considering whether or not your article will be published as open access or non-open access, and then select the most appropriate option.

Open Access Articles

So that we have the necessary rights to publish your article, we ask you to grant a non-exclusive licence to publish. (We do not ask you to transfer your copyright to us.) A non-exclusive licence means that the rights needed to publish the paper are granted to the journal owner, on a non-exclusive basis and the ownership of the copyright remains unchanged. Select the correct form from the choice of two in the table below.

In open access there is a fundamental principle that content should not only be accessible but also be freely reusable for the good of research and humanity. We comply with this principle by asking you to select, within your form, a Creative Commons licence. The CC licence you choose will determine how readers can use your article.

Who are you and who owns the copyright?

I am the sole author and I own the copyright in the article
OR
I am one of two or more authors and we jointly own the copyright in the article
OR
I am the sole author and my employer (government or non-government) owns the copyright in the article
OR
I am one of two or more authors and one or more of our employers (government or non-government) jointly own the copyright in the article

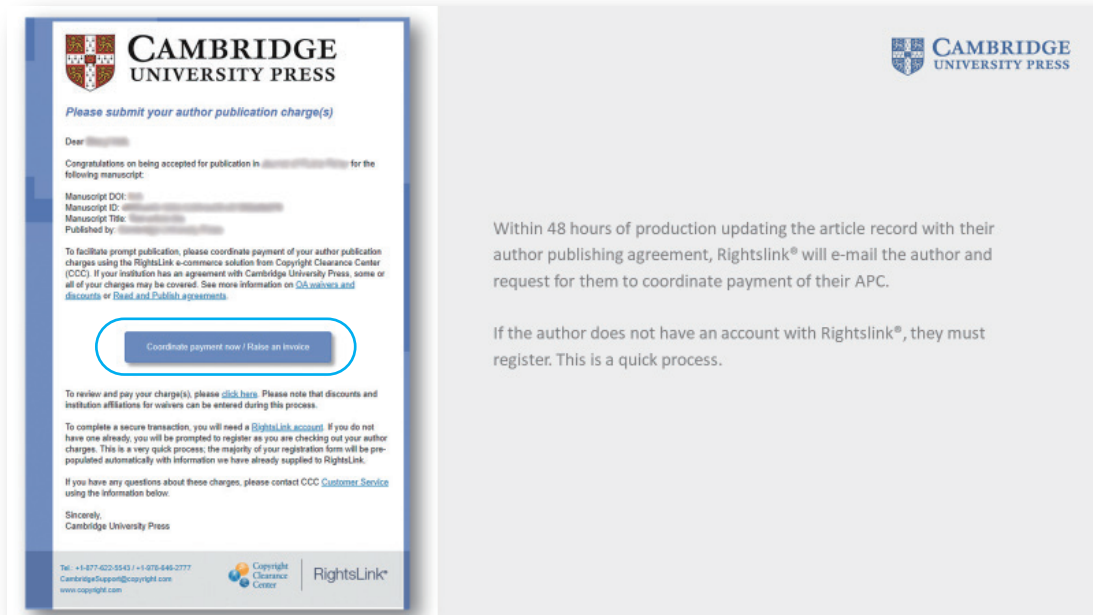

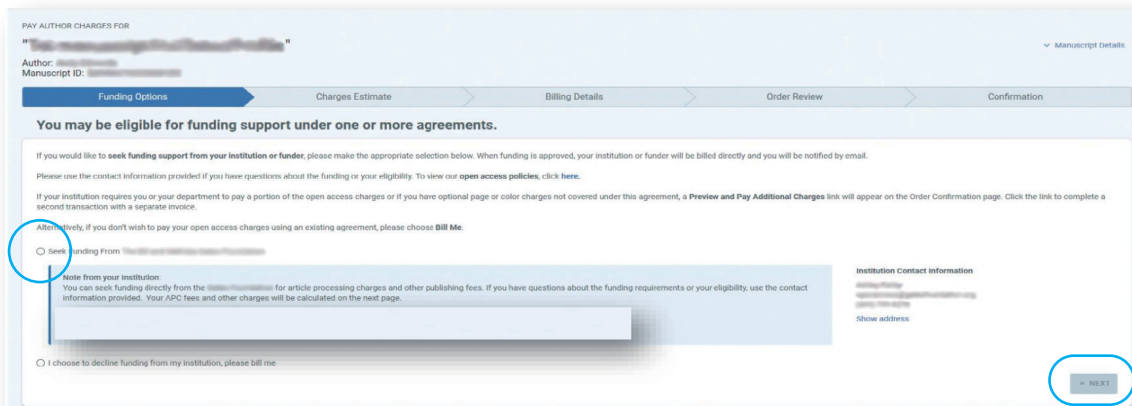
2. 作者若決定要以 OA 形式出版文章，會於 48 小時內收到 Rightslink 寄來的信：信上會要求作者登入 Rightslink，並支付 APC。

*RightsLink Author 系統由 Copyright Clearance Center 直接管理，使用者需建立 RightsLink 帳號以查看紀錄及付費。



3. 點選信中的藍色方框登入 Righthstlink，申請免除 APC：

- 沒有 Rightslink 帳號者，請先註冊再登入。已有帳號者，請直接登入。
- 登入 Rightslink 後，畫面上會顯示機構名稱。
- 請選擇【Seek Funding From.....】的選項，再按下【Next】。
- 按下【Submit】，即完成申請免除 APC 的所有步驟。
- 接下來，申請通過後，作者會收到 Rightslink® 確認信，代表已確認免付 APC。
